## **COUNCIL UPDATES**

Ward System – On April 19, 2017, the Municipality passed Bylaw 2017-035 to end the ward system of voting in Hastings Highlands. Electors for the 2018 Municipal Election would be choosing their five (5) councillor representatives on an at-large system along with their choice of Mayor and Deputy Mayor. Since that time, an appeal letter has been received and the matter is now in the hands of the OMB (Ontario Municipal Board). If a decision is reached before the end of 2017 with the OMB upholding Council's decision, an at-large system of voting will take place for the 2018 Election. If no decision is made by the OMB by the end of 2017, the matter will be delayed until the 2022 Municipal Election.

Election October 22, 2018 – Eligible electors will have the choice of voting by Internet or Telephone. This will be our first election using these two voting options. Internet & Telephone voting provides convenience, accommodates changing lifestyles, demanding work schedules; enhances accessibility for students studying away from home, those travelling, shift workers, infirmary persons and persons with language barriers, etc. The ability to vote would be opened as many as 10 days to two weeks before Election Day. A voting kiosk will be available to the public.

## **2017 FINAL TAXES**

This Tax Bill is based on your 2017 MPAC Assessment multiplied by the 2017 Tax Rates. It is due in two installments.

NSF or any returned cheques are subject to a processing fee of \$35.00.


### **OVERDUE ACCOUNTS**



Capital Budget \$1,463,138 Our capital budget highlights include; 1 new plow truck, 1 new fire pumper, new fire bunker gear, 1 new roads pot hole patching machine and over 40 kms of road construction. This includes over 30 kms of gravel resurfacing for a variety of roads and over 10 kms of paving planned for McDonald Mine Rd, Siberia Rd, Musclow Greenview Rd and South Baptiste Lk Rd.

Municipal Reserves \$4,582,477 December 31, 2016 We continue to maintain a healthy reserves balance. This is critical because the municipality currently owns and manages an aging infrastructure with over 1,000 lane km of roads, 13 bridges, over 50 fleet/vehicles, over 30 buildings and facilities and 9 municipal solid waste landfill sites, which is the most landfill sites per capital in the province. Having healthy and accessible reserves enables the municipality to better plan for future infrastructure investment. As well, reserves are available for any emergency situation that may arise in a given year. In 2017, Council approved a reserve policy to help improve, maintain and manage the municipal reserves.

**Outstanding Debt** At the end of 2017, our debt will be over 2.3 million. On an annual basis, it costs residents \$450,000 to pay off the existing debt. Council has not approved any additional debt for 2017.

Tax Arrears As the lower tier municipality, we collect taxes (included as part of your tax bill) for the County of Hastings and the Education System. We are required to pay these entities regardless if residents pay their taxes to us. Outstanding tax arrears do fluctuate throughout the year; however, as of January 1, 2017 this totaled over \$1.7 million, which has been progressing in a downward pattern since 2014. Council and staff are working hard to reduce the amount of arrears owing using a variety of inhouse and legal tactics/processes.

Investing In Our Future As part of Councils corporate strategic plan, a 5 year infrastructure and financial plan is being prepared to maximize the use of public dollars. This plan will ensure that the right investments are made at the right time for the community. This plan will be an important component of all future municipal budgets.
