115 Rangers Road, being Part Lot 30, Concession 7, and Lot 12 on Plan Subject Property:

M59, in the Geographic Township of Herschel, now the Municipality of

Hastings Highlands as seen on the key map attached.

**Purpose of Application:** To provide relief from

a) Section 5.9.2 i) – No development or site alteration within 30 metres

of the high water mark.

b) Section 5.9.2 ii) – Setback of 30 metres from a slope.

c) Section 10.3 a) v) – Minimum setback of 30 metres from rear lot line (i.e. high water mark).

d) Section 10.3 c) i) – A 30 metre natural vegetative buffer strip in width.

e) Section 26.3 iii) - Minimum setback of 30 metres from a lake.

To replace an existing dwelling with a new dwelling, with attached entryway Effect Of Application:

and attached deck with stairs, as close as 20.3 metres to Baptiste Lake, 30.8 metres to the front lot line (i.e. the road), and 3.6 metres to the side lot line

(with a roof overhang as close as 2.4 metres to the side lot line).
