Take Notice That an application under the above file number will be heard by the Committee of Adjustment on **Thursday, July 30, 2026, at 8:30 A.M.**, at the Municipal Office Council Chambers, 33011 Highway 62, Maynooth under the authority of Section 45 of the *Planning Act*.

Subject Property: 80 Horseshoe Lane, being Part Lot 25, Concession 12, and Part 1 on 21R19091, in the Geographic Township of Monteaale.

Purpose of Application: To provide relief from

- Section 5.9.2 i) – No development or site alteration within 30 metres of the high water mark.
- Section 5.9.2 ii) – No development or site alteration within a minimum distance of 30 metres from a steep and/or unstable slope
- Section 8.3 a) iii) – Minimum of 10 metres (32.8 ft.) from the front lot line
- Section 8.3 c) i) – A 30 metre natural vegetative buffer strip in width shall be maintained.
- Section 26.3 iii) – Minimum setback of 30 metres from a lake.

Effect Of Application: To allow the construction of an attached 10.3 m² (111 sq.ft.) mudroom, a 78 m² (840 sq.ft.) garage with a 44.5 m² (479 sq.ft.) storage loft, attached 5.2 m² (56 sq.ft.) front covered deck, attached 19.9 m² (214 sq.ft.) rear covered addition area with a height of 4.9 metres (16.75 ft.) that is as close as 9.2 m to the front lot line, +/- 17.3 m (57 ft.) to the high water mark of Graphite Lake, and +/- 5.8 m (19 ft.) from a steep and/or unstable slope.

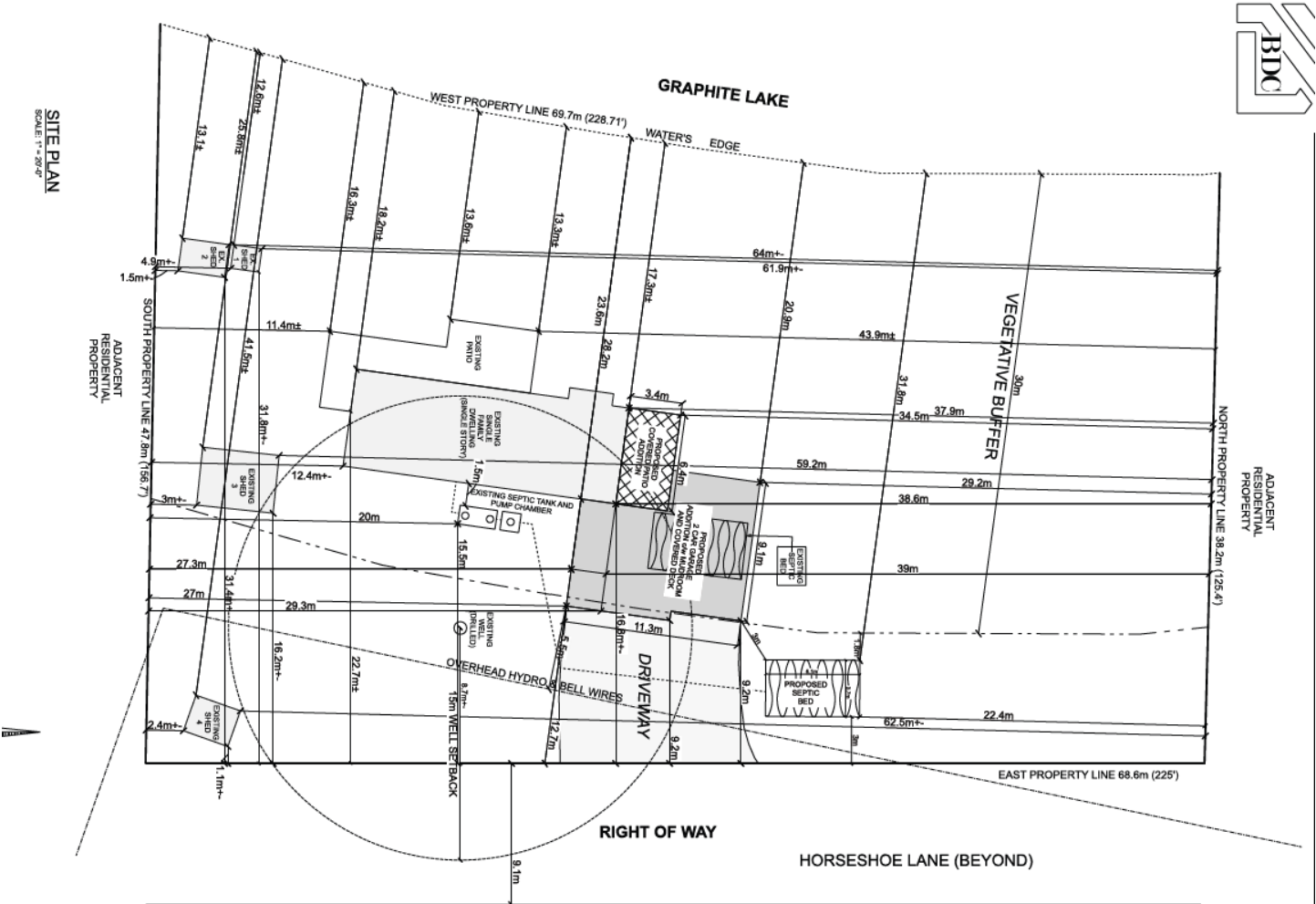

Notice Of Decision: A certified copy of the decision, together with a notice of the last day for appealing to the Ontario Land Tribunal shall be sent, not later than 10 days from the making of the decision, to the applicant, and to each person or their counsel who appeared virtually at the hearing and who filed with the secretary a written request for notice of the decision. *Planning Act*, R. S. O. 1990, C. p. 13, S. 45 (10). Note: an application can only be appealed by the applicant, a public body or specified person (as defined by the *Planning Act*).
